The main aspects of the use of distance education technologies are considered in improving the qualifications of leaders and editors working in the vocational education system. In the professional education system, the periodicity of professional development and retraining is organized differently for different specialists, managers and editors, and is held once every 3-5 years, and in shorter periods if necessary. The process of training and retraining is carried out in training institutes of higher education institutions and in educational centers that have the right to retraining. It is expedient to

- development and development of high-quality, modern information technologies.

The conditions and opportunities listed above indicate that there is a demand and need for distance learning . There are different models and forms of distance learning in the educational system. They are subject to the following terms of use:

- level of development of communication and transport means;
- traditions used in education;
- geographical conditions (for example, the territory of the country, remote location, climate);
- the general level of information and computerization of the country;
- the distance education system, availability of scientific editors and their potential, etc.;
- differ from each other by the level of use of information and communication technologies in the educational process.

It is appropriate to add the following to the main purpose of distance education:

- to meet the needs and demands of the audience for education and provide an educational environment;
- to create an equal opportunity for all students abroad, all regions of the country and those who wish to receive education;
- to create an opportunity to get additional education in parallel with the main work activity and basic education;
