cooperation and cooperation of subjects of the education system (family, educational organizations, society and the state).

The formation of a spiritual worldview among students based on the pedagogy of cooperation includes: assistance in improving the discipline and success of each student, including through monitoring attendance and academic performance; ensuring the involvement of all students in activities in priority areas of their education and socialization; promotion of successful socialization of students by organizing events and activities that ensure the formation of their experience of socially and personally significant activities, including using the opportunities of youth social movements, creative and scientific communities; individual support for each student based on the study of his psychophysiological characteristics, social and living conditions and family education, socio-cultural situation student development in the family; formation of information security skills; assistance in the formation of students' motivation to learn, the development of their cognitive interests; support for talented students, including assistance in the development of their abilities; ensuring the protection of the rights and legitimate interests of students, including guarantees of the availability of educational resources.

The activity of a teacher based on the pedagogy of cooperation is defined as: activities for the education and socialization of students carried out with a group as a social unit, including: the study and analysis of the characteristics of a group of students as a small social group; regulation and humanization of interpersonal relations in a group, the formation of a favorable psychological climate, tolerance and communication skills in a multiethnic, multicultural environment; formation of value-oriented unity in the group in relation to national, universal, family values, healthy lifestyle, active citizenship, national patriotism, a sense of responsibility for the future of the country, recognition of the value of achievements and self-realization in educational, sports and creative activities; organization and support of all forms and types of constructive interaction of students.

The implementation of educational activities in cooperation with the parents of students on the basis of the pedagogy of cooperation, includes: involving parents in cooperation in the interests of students in order to form unified approaches to education and create the most favorable conditions for the development of the personality of each student; regularly informing parents about the specifics of the educational process during the school year, the main substantive and organizational changes, about extracurricular activities and group life events; coordination of relationships between parents of students and other participants in educational relations; assistance in improving the pedagogical competence of parents by organizing targeted activities, providing advice on education and upbringing, and personal development of students.

Educational activities in cooperation with the teaching staff based on the pedagogy of cooperation include: interaction with members of the teaching staff in order to develop common pedagogical requirements, goals, objectives and approaches to teaching and educating students; interaction with the college administration and teachers of academic subjects on issues of monitoring and improving the effectiveness of educational activities of students and the group as a whole; interaction with a psychologist and a social pedagogue on the issues of studying the personal characteristics of students, their adaptation and integration in the group team, building and correcting individual trajectories of personal development; interaction with teachers on the inclusion of students in various forms of activity: intellectual and cognitive, creative, labor, socially useful, artistic and aesthetic, physical culture and sports, interaction with teachers based on the pedagogy of cooperation on the issues of involving students in the system of extracurricular activities.
