#### 4. Implementation in the Classroom

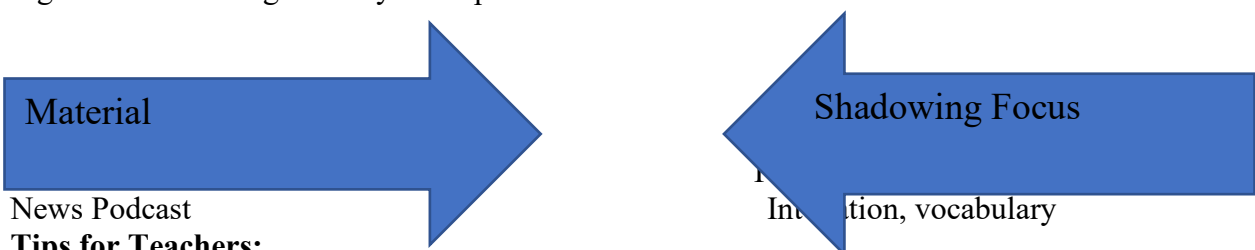
##### Example 1: Shadowing with Stories
