Abstract. From the point of view of a pragmatic approach, the use of punctuation marks makes the text more clear, understandable and communicatively effective. For example, a period indicates the end of a sentence, an exclamation mark expresses emotion, and a dash is used to indicate additional explanation or a contrasting thought. At the same time, the position and frequency of punctuation marks help determine the tone of the text, its formal or informal character. Taking into account the pragmatic aspect in research is important in interpreting the text, translating and creating speech. The comma (,) grammatically separates the structure of a sentence, and pragmatically indicates a pause, emphasis, and contrasting thoughts within a sentence.[2]

From a pragmatic point of view, the use of punctuation marks helps determine the tone, emotionality, and effectiveness of communication. For example, in emails, the position of the comma and period determines the informal or formal tone of the text. In social networks, exclamation marks and dashes are widely used to reflect the writer's emotions, draw the reader's attention, and convey humor or warning.[3]

The use of punctuation marks varies depending on the context of the text and the listening audience. For example, in official texts, scientific articles, or business letters, semicolons and commas are used more for grammatical functions. In informal texts and Internet communication, exclamation marks, dashes, dashes, and brackets are used more to increase emotionality. Studies show that the practical use of punctuation marks is an important indicator in interpreting speech and text.

From a pragmatic point of view, punctuation marks play a significant role in determining the rhythm of the text. Pauses between sentences, emphasis, contrasting thoughts, and emotional

The results of the study showed that punctuation is not only a means of determining the structure of a sentence, but also plays an active role in expressing the intention of the subject of speech, emotional tone, and meanings directed at the listener.
